NOTE 1

- a. When gathering service is performed from all leases, except those noted in (1) below, [U] 60.65¢ per barrel will be added to the rates named in the above columns:
 - (1) from Dagger Draw, [U] 127.73¢ per barrel will be added; provided, however, that an incentive rate of [U] 96.32¢ per barrel shall be assessed to any Shipper that has entered into and has an effective dedication agreement with Centurion or any Shipper shipping on behalf of a producer that has entered into and has an effective dedication agreement with Centurion with respect to gathering and trunk line service from Dagger Draw to Artesia Station.
- b. When gathering is performed into Artesia from the following system, the rate indicated below will be added to the main line rates named above:
 - from the Pecos System, Eddy County, New Mexico – [U] 127.10¢ per barrel.

TRUCK UNLOADING FEE:

Where trucks are unloaded on Centurion’s main line, a special handling charge of [U] 21.17 will be added to the trunk line rate in effect; where trucks are unloaded at Artesia Station, a special handling charge of [U] 21.17¢ per Barrel will be added to the trunk line rate in effect.
