Centurion Pipeline L.P. ("Centurion") hereby submits for filing Tariff No. 28.1.0 to be effective February 1, 2023. Tariff No. 28.1.0 is a joint tariff between Centurion and Ironwood Midstream Energy Partners, LLC. Centurion is filing Tariff No. 28.1.0 to include new language in the tariff clarifying that all transportation charges for movements under the tariff will be assessed on the net volume received, before any adjustments for losses. Exceptions to the Centurion Pipeline L.P. Rules and Regulations, Tariff No. 1.8.0 or subsequent reissues thereof:

For movements under this joint tariff, [W] <u>transportation charges will be assessed on the net</u> <u>volumes received</u>, <u>before any adjustment for losses</u>. A a pipeline loss allowance of one tenth of one percent (0.1%) will be deducted from the quantity of Crude Petroleum received into Centurion's system to cover shrinkage, evaporation, and other normal losses that occur during the transportation of Crude Petroleum on Centurion's system under this joint tariff. Additionally, a shipper shall be responsible for its pro-rata share of actual gains and losses of Crude Petroleum that occur during transportation on Crude Petroleum on IMEP's system under this joint tariff.
