**ROUTE:** West Texas Gulf Pipe Line Company LLC's interest from Colorado City, TX to Longview, TX; then Permian Express Partners LLC's interest from Longview, TX to the interconnect with the Crimson Pipeline in West Baton Rouge Parish, Louisiana.

\*The incentive rate will apply to any shipper that has executed a Transportation Services Agreement (TSA) with Carriers on or before May 31, 2021 committing to ship, or pay a deficiency for failure to ship, a minimum quantity of 10,000 barrels per day of Crude Petroleum for a minimum term of thirty (30) months. Any shipper that desires to review the form TSA must first execute a confidentiality agreement. A confidentiality agreement may be obtained by contacting the tariff compiler via email at [tariffs@energytransfer.com](mailto:tariffs@energytransfer.com). Once the confidentiality agreement is executed, the tariff compiler will deliver the form TSA to the interested shipper.

^ Shippers that have executed a TSA may be entitled, from time to time and in accordance with the terms and conditions set forth in the TSA, (i) to ship barrels from an intermediate origin point on the Pipeline System and (ii) to ship barrels to the Destination Point(s) (as defined in the TSA). If such intermediate point shipments under (i) above are accepted by Carriers in accordance with the terms set forth in the TSA, then the committed rate applicable to such shipments shall be equal to the then-effective Deficiency Rate (as defined in the TSA).
